

PRIVACY AND PERSONAL DATA PROTECTION DISCLAIMER

1. Collection of Personal Data

By completing any form, registering on our website, or making a contribution through any of our platforms (including but not limited to Pos Malaysia counters, online portals, or mobile applications), you hereby consent to the collection and processing of your personal data by **Yayasan Waqaf Pendidikan Anak Yatim atau Miskin Malaysia (YAWATIM)** and **Pertubuhan Kebajikan Anak Yatim Malaysia (PEYATIM)**.

The personal data collected may include, but is not limited to, your name, identification number, telephone number, email address, mailing address, banking information, and any other related personal details.

2. Purpose of Data Processing

Your personal data will be processed for the following purposes:

- To facilitate ongoing fundraising campaigns, including direct debit, auto-debit, and recurring contributions.

1. Pengumpulan Data Peribadi
